## **Written Procedure**

According to Article 41(8) of Regulation (EU) No 2018/1861 and Article 56(8) of Regulation (EU) 2018/1862, Member States shall send to the Management Authority the list of competent authorities which are authorised to search directly the data contained in SIS pursuant the referred legal instruments.

In addition, in accordance with common Article 7 of Regulation (EU) 2018/1861 and of Regulation (EU) 2018/1862, Member States shall inform the Management Authority of their N.SIS office and their SIRENE Bureau. The Management Authority shall ensure the annual publication of the list in the Official Journal (OJ) of the EU.

In line with Article 24(3)(v) of the Agency's establishing Regulation, the Executive Director shall submit to the Management Board for adoption, the draft annual list of authorities for N.SIS II offices and SIRENE Bureaux for publication. Moreover, the Management Board in accordance with Article 19 (1)(mm) of the same Regulation, has to ensure the annual publication of the list of competent authorities authorised to search directly the data contained in SIS pursuant to Article 41(8) of Regulation (EU) 2018/1861 and Article 56(7) of Regulation (EU) 2018/1862, together with the list of Offices of the national systems of SIS (N.SIS) and SIRENE Bureaux pursuant to Article 7(3) of Regulation (EU) 2018/1861 and Article 7(3) of Regulation (EU) 2018/1862 respectively.

The SIS II Advisory Group was consulted on the draft lists between 19 August and 2 September 2022, no comments were received. On 7 September 2022, a written procedure was launched in the SIS II Advisory Group for the adoption of an opinion of the draft lists (documents 2022-341 and 2022-342). By the deadline of the written procedure, 22 September 2022, no comments were received and the SIS II Advisory Group gave its positive opinion to the lists.

On 29 September 2022, the draft lists (documents 2022-341 and 2022-342) were sent for the decision of the Management Board via written procedure. By the deadline of the written procedure on 4 October 2022 C.O.B., no objections by the Board members with the right to vote were received.

Considering the above, and in accordance with the provisions of Article 8 of the Agency's Rules of Procedure, the Management Board decides to adopt the following decision by written procedure:

## The Management Board decides to adopt the SIS II list of authorities, N.SIS II offices and SIRENE Bureaux as set out in documents 2022-341 and 2022-342 and asks to ensure their publication.
